SUBJECT: 100 Block of Olive Street – Parking Changes Appeal

RECOMMENDATION: Motion that the Transportation and Public Works Commission consider the appeal of the Public Works staff decision to install designated single space markings "parking T's", a designated shuttle drop off zone, and additional red curb markings on the 100 block of Olive Street between Mission Street and Toledo Street, and at the close of the hearing, deny the appeal.

BACKGROUND: In August of 2019, the City of Santa Cruz Public Works Department received an initial request from the property owner, Ada Ross, to restrict overnight parking, install single space markings, and other suggested parking restrictions at the 100 block of Olive Street (Attachment 1). Staff conducted a field review of the parking conditions on Olive Street and completed a layout to include designated "parking T's" or single space markings, a designated shuttle drop off zone for University of California, Santa Cruz (UCSC) bike shuttle program, and additional red curb markings.

This review was concluded in March 2020 but posting the notice of change was delayed due to the current Covid-19 pandemic. Once regular work duties resumed, the public notice of change was posted as required for a 14 day period in June, at which time Alicia Kuhl officially appealed the proposed changes (Attachment 2).

DISCUSSION: Following staff's review, staff determined the original request could be satisfied with the following changes to the parking configuration and could not determine sufficient evidence to deny the original request. The layout enhanced the red curb markings near the fire hydrants located on Olive Street, provided accommodation for the UCSC bike shuttle, and designated eight single space parking stalls while leaving the existing restrictions in place.

Existing Parking Constraints (Attachment 3):

- 2 hour parking limit except by permit 8AM- 6PM
- Two parking spaces designated for Zip-Car program
- Two parking lot ingress & egress driveways

Proposed Changes/Additions (Attachment 4):

- Single space markings "Parking T's" total of eight designated parking spots
- Red curb no parking at dead end adjacent to fire hydrant
- Red curb no parking at corners near Mission Street adjacent to and across from fire hydrant

- Install designated UCSC bike shuttle parking
- No changes to existing constraints; they will remain in place

The appeals process has been followed by staff as described in Municipal Code 10.16.015. Staff posted the proposed changes Public Notice for the required 14 day at the site and mailed the required notice to adjacent properties within 300 feet of the proposed change (Attachment 5). During the 14 day period we received an official appeal and a number of communications in support and in opposition to the proposed changes (Attachments 6 & 7). Staff recommends that the Transportation Public Works Commission considers the appeal and deny the appeal at the close of public hearing, pursuant to Municipal Code 10.16.015 section (g).

10.16.015 TRAFFIC-CONTROL DEVICES – CITIZEN REQUEST APPEAL PROCEDURE.

Any person who has requested the installation or removal of a traffic-control device may appeal the traffic engineer's decision to approve or deny the citizen request in accordance with the following procedure:

- (a) All citizen requests for the installation or removal of traffic-control devices shall be directed to the city traffic engineer in writing. After reviewing the request, the city traffic engineer shall approve or deny the request.
- (b) If the traffic engineer, in response to a citizen request, approves the installation or removal of a traffic-control device, the traffic engineer shall notice all affected occupants, business and property owners within 300 feet of the traffic-control device. This notice shall be sent fourteen days prior to the initiation of a work order for the installation or removal of such traffic-control devices. In addition the traffic engineer shall cause a copy of the notice to be posted at the site where the traffic-control device is to be installed or removed. The person who initiated the citizen request, and all affected occupants, business and property owners within 300 feet of the traffic-control device, may appeal the traffic engineer's decision to approve the installation or removal of a traffic-control device during this fourteen-day review period.
- (c) If the traffic engineer, in response to a citizen request, denies such request for the installation or removal of a traffic-control device, the person who requested such installation or removal shall have fourteen days from the date of the traffic engineer's written notification of denial to appeal the traffic engineer's decision.
- (d) The appeal must be in writing and submitted to the city public works department. The written letter of appeal must state that it is made from a decision or action taken by the traffic engineer to install or remove traffic-control devices. The appeal must be signed by the appellant or appellant's representative, and set forth the mailing address to which the traffic engineer may direct notice of public hearing on the appeal. If the final day for filing an appeal occurs on a weekend day or holiday, the final filing date shall be extended to the next following work day.
- (e) If no appeals are received during the fourteen-day review period, the traffic engineer may initiate a work order to install or remove the traffic-control device.
- (f) All appeals will go to the city transportation commission for a public hearing. The traffic engineer will notice the appellant, occupants, businesses, and property owners within 300 feet of the traffic-control device at least seven days prior to the public hearing scheduled for the city transportation commission's agenda. In addition the traffic engineer shall cause a copy of the notice to be posted at the site where the traffic-control device is to be installed or removed.
- (g) Upon completion of the public hearing, the city transportation commission shall either uphold or deny the appeal.
- (h) The city transportation commission's decision may be appealed to the city council in accordance with Chapter 1.16 of this code.

(Ord. 96-20 § 2, 1996).

Hi Brian and members of the Transportation Public Works Commission,

My name is Ada Ross. My husband Peter Ross and I own the last house on Toledo, right across the empty lot from Olive St. We bought this house with the intention of moving into it when we retire (in a couple of years). Until we do – it is rented.

In July of 2019 we were informed by our renters that they are facing some problems with RVs camping on Olive St. They complained about noise, partying, evidence of drug dealing, fights and trash. Our renters, a family of 3 Santa Cruz natives who own a property elsewhere in Santa Cruz, but wanted to move to this school district, were concerned, and started keeping a log of what they witnessed and of their actions, such as calling police, vehicle abatement, etc. (see attached in this document).

Their concerns grew when they found out that one of the campers had posted their identity on Facebook as "false complainers" (see attached in this document). The picture on the post was of their daughter, and that worried them even more. They felt threatened and bullied, their daughter was afraid to walk unaccompanied in the area, and the noise and disturbance started to affect their lives. The distance from their bedroom window to the camped RVs is only 100 feet.

Once we received the complaint, we started a "campaign" to try to bring a change to the parking situation on Olive St. We were concerned about the growing "campground" so close to our property, and we found out that we are not alone: many residents expressed their dismay about the camping increasing and going un-checked.

We wrote letters to everyone on the City Council, talked to and sent letters to SCPD, Vehicle Abatement office, City Manager Office, District Attorney Office, CVS, Owners of CVS property & Public Works. We started organized the neighborhood to write letters to voice their concerns. Those letters from last year, along with letters we wrote to City officials, are all attached bellow.

Our renters, who intended to rent from us for 6 years, until their daughter graduated from High School, moved away after one year only. They could not cope with the disturbance and the harassment.

We regret that we could not provide them with safe and hassle free environment, and "quiet enjoyment" required by our lease.

A year later, here we are. The RV camping continues, but you (Public Works) are trying to help and bring a change to the parking configuration on Olive. We hope very much that you will succeed.

We understand and acknowledge that the homeless problem in Santa Cruz is enormous, and that there is no one, easy solution for it. We empathize with those who cannot afford their own homes, owning or renting. We wish that more of our tax dollars could be directed towards a healthy and companionate solution to this problem. However, camping on neighborhood streets is not the solution, and we will continue to fight the negative effects that this phenomenon is having on our neighborhood. We urge you to come up with a suitable solution as soon as possible, to stop the RV parking on Olive St.

Re: Parking Laws changes to Olive St.

Mr. Dettle,

It is our understanding that our request for a change to the parking situation on Olive St. between Mission and Toledo is waiting for your department's decision.

At my meeting yesterday with Chief Mills he recommended that I reach out to you.

We own the last house on Toledo St, across an empty lot from Olive, where transients overnight parking (& day parking also) suddenly became a problem.

Our house was rented to a family of 3, who started to experience issues of excessive noise, screaming in the middle of the night, visible drug dealings – all happening a short distance from their bedroom window.

Several times they called the police when they witnessed a behavior which they were concerned about. Police came sometimes, and sometimes not.

The complains to the PD resulted in a bulling campaign against them, which lead to their decision to move out. The group (under the leadership of Alicia kuhl, a Homeless activist who lives in her RV with her partner and 3 small children) obtained the name of my renters — and the online posts began. My renter's name and her Facebook profile, including a picture of her daughter, was published on a Homeless Advocate Facebook

page https://www.facebook.com/groups/SantaCruzCountyHomelessAdvocates/

with accusations of "false complains" to Police, with threats and smearing, and downright incitements. One just has to follow the responses to the posts to understand why she was driven to moving out. She was scared out of her mind, for her daughter's safety and her own. Additional posts "exposing" and harassing her Facebook friends who tried to come to her defense quickly followed.

The ongoing incitement resulted in an incident of a man jumping the fenced empty lot at 1:30 am on August 28th, reaching my property's fence, and yelling at my renters: "I am a Boogie Man, I am gonna get you both, I am gonna kill you". Police was called, the man was removed from the empty lot, but to our knowledge, nothing else came out of that incident.

We, home owners and tax payers, believe that having to live with this kind of threat and this poisonous environment is unacceptable.

Our renters have moved out only a year after moving in. They had moved to our house so that their daughter can attend the school of their choice, and were going to rent it for 6 years, until her graduation. We truly regret the fact that our responsibilities as landlords to this family, providing them with a safe home, could not be met.

We ask that you consider our request for a change on that strip of Olive St. We understand that in the current environment in the City, with the Homeless crisis and political wars, parking change to "no night" parking is the only chance we have to return to sanity.

Many of our neighbors are concerned about safety due to the night parking there, and several of them sent emails regarding the issue in support of a change. Jon Bush (SCPD) has copies of all the emails and other data we have collected in the past two months. He will be happy to share them with you if requested.

This is an attempt to break up the Olive Branch safe parking vehicle dweller encampment. It has been up and running for over a year, and if this tactic is successful it would essentially break up an encampment during shelter in place which is against the CDC guidelines. It is important to note that we are not being offered a safe parking alternative, and marking the spots is a direct attempt to make sure that RV's cannot fit any longer.

I would also like to point out that the signs themselves are deceptive.

#1 The sign says there are no current parking restrictions and there are. Currently there are signs posted that say 2 hour parking except by permit Monday through Friday 8 a.m. to 6 p.m..

Essentially this means that during the day the parking spots are readily available for people as well as the UCSC shuttle bus. However if they were to slot the spots, the encampment that Parks here at night time especially the RVs would no longer be able to do so.

#2 they have only placed a few of these signs on the street for public view, the signs are tiny they are hardly noticeable, I fear this is an attempt to lower the public opposition towards this maneuver.

In summary, there is no justifiable reason to do this! Parking is readily available for the community during the day, and the only reason they would do this is to stop us from being able to safely Park here in the nighttime. I believe this is a violation of breaking up encampments during a pandemic, it is a way to sideline the CDC recommendations.

As a resident of the City of Santa Cruz (I live on Kalkar Drive), I'm dismayed to see so many RVs illegally parked on our streets. To my knowledge, it's illegal to park an RV on the street for more than 3 days. My wife and I have considered purchasing a travel trailer, but one of the considerations is our ability to park it on our own property. Why should residents be unable to use the street for parking while non-residents are able to do so?

There are two steps the city should take:

- 1. Delimited spaces on streets such as Olive and Delaware. If your vehicle doesn't fit, you don't park there.
- 2. Designated parking lot for RVs. This lot should be available to anyone who (a) maintained a residence house or apartment in the City of Santa Cruz for 12 out of the previous 24 months or (b) has regular employment in the City of Santa Cruz.

I want to ensure that community members have a safe place to live in their vehicles - we owe it to contributing members of our community. I feel no such obligation for those who just show up here because it's a nice place to live; evidence shows that we have many such people whose RVs are clogging our streets.





Dear Mr. Jatho:

Disability Rights California (DRC) is a nonprofit organization that advocates for the rights of people with disabilities. We submit this letter in opposition to the Public Works Department's proposal to delineate parking spaces on Olive Street between Mission Street and Toledo Street. The proposed delineations appear to be too small to accommodate a recreational vehicle (RV). They effectively prohibit RVs from parking on Olive Street, resulting in the dispersion of people who live in their RVs from one of the few overnight parking locations available to them. The proposed changes will be especially harmful to people with disabilities who live in RVs. We therefore urge the Public Works Department not to proceed with the proposed changes.

Although the City of Santa Cruz does not explicitly prohibit people from using their RVs for shelter, it has imposed so many unnecessary restrictions on overnight parking that it has become extremely difficult to locate a safe place to park overnight and rest. AFC's Safe Spaces program provides some relief, but is inadequate to meet in full the needs of the City's residents who live in their vehicles. The Safe Spaces program has substantive requirements that exclude potential participants from the program, and its application process

can be burdensome for people with limited resources. Those considerations aside, there simply are not enough spaces available for every person in Santa Cruz who lives in their vehicle. Accordingly, it is important for the City to preserve overnight parking spaces so that people who use their vehicles for shelter but are unable to participate in Safe Spaces can still live and work in the City.

Protecting overnight parking spaces is especially important for people with disabilities. DRC has represented a number of Santa Cruz residents experiencing homeless, many of whom use their vehicles as housing of last resort. Having some type of shelter is crucial for people with disabilities because the alternatives—congregate shelter or sleeping on the street—can have life-threatening effects on a person's already compromised health. Being able to shelter in a vehicle overnight allows a person with a disability to rest and manage the effects of their disability. This is especially important during the COVID-19 pandemic, when sheltering in place is necessary to control the spread of the virus.

The proposed parking changes contradict CDC guidance on allowing people experiencing homelessness to shelter in place. On its website, the City maintains a list of Frequently Asked Questions about COVID-19 and homelessness. One of the questions asks: "Is the City towing/what is the City doing about [people experiencing homelessness] living in cars?" The document responds: "Police are citing vehicles, and towing only for unusual circumstances or if an officer deems a vehicle a hazard or nuisance. While citing has not stopped camping it has reduced it. If [people experiencing homelessness] are using vehicles to shelter-in-place CDC guidelines discourage dispersing them [emphasis added]." The proposed parking change will do exactly what CDC guidelines discourage: It will make a safe parking site unavailable to people who live in their RVs, forcing them to disperse.

People who live in their RVs have been using Olive Street as an overnight parking location for over a year. The sudden change in parking rules effectively disbands a long-standing encampment without providing adequate notice or alternative shelter. This action raises Due Process

concerns. In addition, it conflicts with public health objectives by forcing people who live in their RVs to relocate when they should remain in place. The Public Works Department has not put forth a compelling reason for the proposed changes, and certainly not a reason why these changes need to happen during the pandemic. In light of these facts, we urge the Public Works Department not to proceed with the proposed changes. They are unnecessary and, more importantly, violate the rights of people experiencing homelessness to shelter safely in their vehicles during the pandemic.

Dear Mr. Jatho,

I write on behalf of the National Law Center on Homelessness & Poverty ("Law Center") to express our opposition to proposed changes to parking on Olive Street between Mission and Toledo. The proposed change will reduce the number of lawful places where people who live in RVs are able to park and safely shelter in place during the COVID-19 pandemic. By reducing the number of places where people who live in RVs may safely park and shelter in place — without offering any alternatives to individuals and families living there — the City of Santa Cruz threatens the health and safety of its vehicle residents and the public at large.

The Law Center is the only national legal advocacy organization dedicated solely to ending and preventing homelessness. We have over 30 years of experience in policy advocacy, public education, and impact litigation. We have published numerous reports, including *Housing Not Handcuffs 2019: Ending the Criminalization of Homelessness*, which includes a section about the negative public health impacts of policies that displace homeless people from public space. We have also compiled best practices and other resources for communities working to address homelessness and curb the spread of the deadly coronavirus, which you can find on our website at https://nlchp.org/coronavirus/.

Even though Santa Cruz struggles with a lack of affordable housing and a resulting homelessness crisis, the City has not taken adequate steps to ensure that people who live in vehicles for lack of other housing options have sufficient safe and lawful places to park. Proposed changes to parking on Olive Street between Mission and Toledo would add to the patchwork of regulations that make it practically impossible to safely and lawfully park a vehicle home in the City of Santa Cruz. This is a step in the wrong direction, and an especially harmful act during the COVID-19 pandemic.

RVs are often housing of last resort for people who are too poor to afford traditional housing, such as families with children, seniors, and people with disabilities. Olive

Street between Mission and Toledo, a non-residential area that does not have through traffic, has been one of the few places in the City where people who live in RVs can stably and safely park, which they have done without incident for over a year. Now, the City seeks to suddenly displace this group of people from that location. Worse yet, the City seeks to displace them during the midst of the COVID-19 pandemic, and without offering the people living there any adequate alternatives for parking and maintaining safe shelter. This will create serious risks of harm to people who will no longer have access to a safe, lawful place to park their only available form of private shelter, and who risk losing those private shelters as a result.

This action runs directly counter to guidance from the U.S. Centers for Disease Control and Prevention (the "CDC") which on multiple occasions has advised that cities not displace people experiencing homelessness from their private shelters and outdoor communities during the COVID-19 pandemic. In its Interim Guidance for Responding to Coronavirus Disease 2019 (COVID-19) among People Experiencing Unsheltered Homelessness, the CDC states: "Unless individual housing units are available, do not clear encampments during community spread of COVID-19. Clearing encampments can cause people to disperse throughout the community and break connections with service providers. This increases the potential for infectious disease spread."

The rationale for this guidance extends equally to vehicles as to tents because safe, stable places to access private shelter, even if the form of shelter isn't optimal, is inavaluable to protecting public health during the COVID-19 pandemic. Indeed, a growing body of research has underscored the importance of following CDC guidance to preserve not only the health and lives of people who lack housing, but to protect the health and lives of the public at large. One example is a a study released by medical practitioners, public health professionals, and social scientists at University of California at Berkeley's School of Public Health in April 2020, entitled "For the Good of Us All: Addressing the Needs of Our Unhoused Neighbors During the COVID-19 Pandemic." The study, based on a review of scientific evidence, concludes that helping unhoused people to properly shelter in place – even if those shelters are vehicles - will help to "flatten the curve", decrease the demand for services from hospitals, and enable communities to lift shelter-in-place orders sooner than if people experiencing homelessness are not sheltered-in-place.

The City of Santa Cruz should be following, not flouting, public health guidance during the pandemic. We oppose the proposed changes to parking on Olive Street. The change will create significant harm to vulnerable people who live in RVs. Moreover, the change violates CDC guidance, and and it unnecessarily risks public health. We spoke on the phone last week in which I made an official complaint against these markings and said I would follow-through with a letter.

Here is why I am making this complaint:

- 1) This street is a non-residential street with no car access to the other side.
- 2) The complaints that are being made are being led by an anti-homeless campaign. If proof is needed during the hearing, they can be presented. Most of the complainers live over a mile away.
- 3) There is ample parking in mostly empty parking lot at CVS and on the streets.
- 4) When people have complained and made a police call, when the police come, all they end up doing is waking up people who are quietly sleeping to find out there is no illegal activity.
- 5) Even if there were any illegal activity, people should be cited accordingly instead of taking away their right to peacefully, quietly sleep.
- 6) This is a safe place for people to sleep.
- 7) Olive St has been kept clean except for the few incidents in which the vehicle owners have woken to find nails under their vehicles and what looks like someone emptied a sharp container full of needles near an RV during the night. What is interesting is that the picture showed up within hours on one of their anti-homeless campaigns.
- 8) People have a right to sleep.
- 9) Many people sleeping there are children, elderly and people with disabilities.
- 10) People living there support one another, help each other, help keep it clean. It is a peaceful, quiet area. Every time I have stopped there in the late evening, I find it very quiet, peaceful, clean and everyone quiet inside with lights turned off. It is their sanctuary, their right to quality of life.
- 11) During the weekday day, people observe the 2 hour limit and during the weekends, the 72 hour move your vehicle.

I could probably come up with 10 more reasons but these are the ones that come to mind.

Bottom line, this is not necessary and only targeted towards people who live quietly and peacefully in their RVs.

Please consider INCREASING the numbers of spaces allowed in the City of Santa Cruz for vehicular parking overnight.

Can you picture small groups of overnight parking organized and managed by the people involved, but with structural support from the City? I can. And I believe the City needs to do EVERYTHING in its power to protect this low-overhead model of housing.

Both tourists and people in transition or living 'on the move,' like students and seasonal workers, as we have in this region, need housing models which they can afford. And some people are living full time in this minimal arrangement, and need to be protected from greater harm.

Many disabled people I have met have been forced into this very compromise for basic shelter (relying on their vehicle for protection) because the City has not been able to integrate special needs and low-income housing into a helpful system for those most limited economically.

I understand the neighborhood distress, but a little bit of organizing and a pinch of education for the public could ease some of the "fear of the unknown" that drives people to panic. I am talking about conventionally houses as well as wheel-housed folks: we've been stuck too long already at the discomforting politics of "pass the buck."

Transparency, and an actual, palpable, genuine concern for ALL kinds of neighborhoods learning to get along, if demonstrated among City employees and electeds, would go a long way toward resolving the fear-based apprehensions that seem too often to overshadow civic dialogue.

Small programmed locations which have the City's blessing can lead to even better arrangements once the vital dialogue is allowed to be heard.

Inclusion is important.

Include EVERYONE in locating more savory locations! Integrate the spaces with overall emergency and helping programs, support services, and basic safety.

Allow linkages that incorporate welcomed feedback. Don't make too many rules, but be ready to actually incorporate and monitor those spaces needed.

I was once a part of "the very first" homeless shelter program evaluation" team to work in the Bay Area, when we reviewed all the early shelters that either served the public or used public resources.

This was early in the 1990s: the one BIG thing we discovered back then was this: there were ZERO accommodations for disabled people who became homeless (not even a single bathroom ramp) in the City.

We have staff support today who are better trained, and most programs now serving a homeless population have more complete and viable policy standards.

But still - where can we put disabled people?

And hospital releases after a mere week or so?

I know of an infant born at Dominican Hospital who died when three days old, after her family was put back onto the streets of City of Santa Cruz. Had I been her mommy, you would have been sued along with the hospital for negligence. In the world of shelter, a disabled person has no way of determining whether an offered couch or cot or corner might be safe for their particular limitations ahead of being there! Not legal. Similar dilemma for families with small children.

As you've noticed, there are a lot more people going through transitions, or otherwise stuck ENTIRELY outside of the helping systems, who really need to be on The Map of existing! Others just need uninterrupted sleep. These are not things the sheltering systems we have here can help with on initial contact.

And we do NOT have much better of a ratio between disabled people (as defined EITHER by federal ADA laws OR by the County's HMIS standards, and shelter access/accommodations.

We need to keep people in their homes, even those homes some believe are inadequate; rather than set up the City for excessive hospital admissions and worse.

And we need to take responsibility — finally — as a City, for the people here who are at risk or frail. Making their lives harder under those circumstances will not protect any of us, please do not TAKE AWAY this very minimalist level of population management. We need to ALL be focusing of creating more bridges for the numerous sheltering gaps.

Everyone seems to expect somebody ELSE to fix the systemic lapses. But we need the shelter parking program as part of a stop-gap until the housing crisis has been managed and access to more adequate housing is possible.

Please keep me informed by email about this citywide concern.

I write on behalf of the Santa Cruz County Chapter of the ACLU of Northern California in opposition to the referenced parking change, which would prevent RVs that poor people use for housing to continue to park in one of the few safe places available to them in the City. Several such vehicles park regularly on this short block, which has no homes and no outlet. It appears that the only motivation for this proposed change is the unfounded fear, hatred, and disgust that some people - who do not live on the block, on Olive Street, or even in the neighborhood - have for homeless people. Particularly in light of the pandemic, it is unsightly, immoral, and unfair to deprive people of a place to park their homes. It is also a clear violation of the spirit of CDC and state guidelines that recommend against disbanding homeless encampments, and the practice of other nearby cities to stop ticketing and towing vehicles that people use for shelter - their only shelter. There does not appear to be any valid or supportable reason for the proposed change. There are no houses on the street, so there are no residents who need these spaces to park their own vehicles. There is ample car parking in the mostly empty parking lot at the adjacent CVS and on the surrounding streets. My understanding is that there have been no health or other problems caused by the people who park there at night, so that they have a quiet, safe place for themselves and their families to sleep. Many people who regularly sleep in their vehicles on Olive Street are particularly vulnerable and in need of a safe place - children, elderly, and people with disabilities. This leads us to conclude that the only reason for the proposed change is to further marginalize and injure the most vulnerable residents in the City, and we strenuously object.

If this same change - striping or restriping in a manner that would make it impossible to park an RV - is being considered elsewhere, such as the Delaware Avenue/Natural Bridges area, we object to such changes on the same grounds.
